During the October 3 PSC meeting, the PSC recommended drafting a letter showing support for preserving State CWA 401 Authority, especially given recent information regarding the infill of the Conowingo reservoir and downstream Chesapeake Bay water quality impacts..

On October 5, The Association of Clean Water Administrators (ACWA), Environmental

Council of States (ECOS), and The Association of State Wetland Managers (ASWM) sent a letter to House Speaker Paul Ryan and Minority Leader Nancy Pelosi regarding pending legislation and its effect on similar concerns. In light of this letter, the PSC should reconsider its intent on a similar letter.

<u>Decision requested</u>: Clarification on the intent of a letter on expectations for addressing increased loads associated with Conowingo infill as part of the Clean Water Act 401 certification.
