Finalize and post "Reducing Pollution Indicator"	No later than April 14
Jurisdictions submit final Milestones	No later than April 22
Process final milestone input decks	April 25, 2016 – April 29

All changes to Phase 6 NEIEN Appendix should be approved by WTWG so states can prepare draft calibration submissions.  [States should be reviewing Phase 6 NEIEN Appendix at this time to suggest changes for WTWG to consider.]	June 1
States are encouraged to revise Phase 6 NEIEN history for July calibration run.	June 30
CBPO likely re-run Phase 6 calibration with new NEIEN historic data.	July
All changes to Phase 6 NEIEN Appendix should be approved by WTWG so states can prepare final calibration submissions.	August 30
Deadline for all partnership input and finalization of methods [Data and recommendations can be submitted at any time prior to this date]	September 30
All historic NEIEN data must be finalized for final Phase 6 calibration.	September 30

#### On your password-protected sites for review:

- Validation reports
  - NEIEN
  - Scenario Builder errors
- Status reports
  - The status of the BMP as draft, retired or N/A
- Date reports
  - BMP is valid as implementation, inspection or maintenance falls within lifespan date range
  - BMP credit expired due to lifespan
- Scenario Builder Submitted Versus Credited
- Background Conditions
- Summary BMPs

- Money resources
  - CBIG and CBRAP Grants
  - For agriculture, introduction of NRCS and FSA data from CBPO
  - Additional WIP Assistance Funding (FY16) EPA will notify the jurisdictions of their respective awards the week of March 7,2016 for:
    - 1) Completion of historical BMP data cleanup; and/or
    - 2) Further development and implementation of BMP verification protocols, procedures, and programs; and/or
    - Development of communication and outreach plans targeted towards local partners in preparation for the development of the Phase III WIPs.
