VI. TMDL Land Policy BMPs Approval

To support the jurisdictions' efforts to account for growth in loads due to changes in land use, the CBP partnership has developed a suite of future land use scenarios that are referred to as "land policy BMPs". These are available in CAST for optional inclusion in each jurisdiction's Phase III WIP and two-year milestones. Land policy BMPs represent aggregations of a variety of policy and programmatic actions implemented by state and local organizations. Each jurisdiction was provided the opportunity to develop custom scenarios based on three categories of land policy BMPs: Forest Conservation, Growth Management and Agricultural Conservation.

<u>Decision Requested</u>: The MB will be asked to approve the land policy BMPs for (optional) inclusion in the jurisdictions' Phase III WIPs and two-year milestones.
