Attachment A: Chesapeake Bay Program Partnership's Phase 6 BMP Expert Panel Scheduling and Modeling Considerations

The Chesapeake Bay Program (CBP) Partnership currently has 17 BMP expert panels underway to inform the calibration of the Phase 6 suite of modeling and decision support tools. Each of these Expert Panels was identified by the Water Quality Goal Implementation Team's (WQGIT) Source Sector Workgroups as priority Expert Panels for inclusion in the Phase 6 suite of modeling tools. However, some of the Expert Panels are experiencing delays in either producing a draft report for Partnership review or delays are incurred during the Partnership review and approval process. Therefore, it is necessary to understand which of these Phase 6 Expert Panels need to be completed by September 30, 2016 in order to meet the final Phase 6 calibration deadline, or those Panels that can be deferred until after the Phase 6 modeling tools are complete.
