

# Wastewater Treatment Workgroup Conference Call Summary Tuesday, September 4<sup>th</sup>, 10:00 AM to 12:00 PM

## **Welcome & Introduction**

### 1. <u>BMP Verification Protocols</u>

- Ning Zhou (EPA-CBPO) reviewed the revised draft verification protocols for Non-sig WWTPs, CSOs, and onsite treatment systems; the protocols are available here:

- Dave Montali (WV DEP) asked for clarification that the draft protocols endorse the jurisdictions' WIPs regarding tracking/reporting of overflows.
  - Zhou agreed that the WIPs probably have more detail than Long Term Control Plans.
- Zhou asked for objections to sharing the verification protocols with the BMP Verification Committee on Wednesday, September 12<sup>th</sup>; hearing none, the protocols were approved.

DECISION: The WWTWG's draft verification protocols will be presented to the BMP Verification Committee on Wednesday, September 12<sup>th</sup> for their review and consideration.

#### 2. Midpoint Assessment

- Jeremy Hanson described a request from the Water Quality Goal Implementation Team (WQGIT) for workgroups to identify their top two or three priorities for discussion at the WQGIT's October meeting; he opened the floor to discuss potential priorities.
  - o Priorities must be sent to the WQGIT by September 18<sup>th</sup>, so WWTWG members need to provide their comments to Tanya, Ning, and Jeremy by COB Friday, September 14<sup>th</sup>.
- Allen Brockenbough (VA DEQ) expressed continued reservations with a supplemental indicator for wastewater, suggesting that the sector already has good enough data.
  - o Montali generally agreed with Virginia's comment, but noted that there is disagreement within the workgroup.
  - o Ron Furlan felt the indicator was not a top priority, noting that Maryland has a strong interest in the indicator but was not present to discuss their view.
- Zhou mentioned loading from minor point sources. Tetra Tech helped with development of original data, but the confidence level is not necessarily high so there may be a need to improve the data by 2017.
  - Eric Aschenbach noted that Virginia already has plans for additional monitoring in the long term, noting that the Tetra Tech data is not ideal.

- o Montali commented that West Virginia felt pretty confident with its data, but they would not object to a more detailed evaluation.
- Montali asked for clarification of how many priorities the WWTWG should select and the scope it should focus on.
  - Zhou noted that the WWTWG did not receive any comments on CSOs, so for now the focus is on wastewater and septic/on-site systems.
- Brockenbough suggested combining the following two bullets into one:
  - Changes to Point Source WLA due to permanent trades such as Septic Connections
  - o Accounting for changes in WLA and Offsets both permanent and annual
  - He thought that "Nutrient loads from Minor Industrial Point Sources" was a top priority for the WWTWG in addition to the preceding two bullets.
- Marty Hurd (Tetra Tech) pointed out Virginia's comment on septic "census" data, and asked if other jurisdictions collected similar data.
  - Brockenbough clarified that VA collects data on new septic permits issued, not septic connections to treatment plants; there's one locality with an allocation for connections of septic systems; no formal policy is in place.
  - Furlan explained that PA does not track or collect comprehensive info on septic systems, but they track the number of systems connected or eliminated; the load from septic systems is negligible relative to the rest of PA's pollutant loads.
  - Montali felt the spatial extent of centralized sewer systems was far too small in the past version of the Model; WV plans to gather data to more accurately understand the number of operating on-site systems.

ACTION: Tanya, Ning, and Jeremy will draft a list of the WWTWG's priorities to share with the WWTWG before sending to the WQGIT.

## 3. Septic Expert Panel Update

- Mark Sievers (Tetra Tech) briefly updated the workgroup on the expert panel's last two meetings in late July and late August.
  - The panel is investigating specific efficiencies for different proprietary systems, given differences in their performance.
  - o For non-proprietary technologies, the expert panel is considering a single BMP efficiency for each technology.
- Ron Furlan asked if the panel is looking at air deposition; Sievers indicated they are not.
- Sievers hopes to have a draft report to share with the WWTWG by December.

- Hurd reviewed the changes and upgrades that Tetra Tech is working on; his presentation contained screenshots examples.

- Hurd had no specific requests, but encouraged the jurisdictions to provide general comments.
- Montali asked about the timeline for the changes; Hurd hoped to have the updates in place in time for 2012 progress reporting, if the bugs are all worked out in time.
- Montali expressed concern that some detail might be lost; he encouraged Zhou and Hurd to meet with Megan Smith from West Virginia.
